## Section 4: FIRST AID MEASURES

**Methods and materials for containment and clean up** Slippery when spilt. Clear area of all unprotected personnel. Wear full protective equipment to prevent skin and eye contact. Collect in an appropriate container or absorb with an inert material (eg vermiculite, dry sand, earth), and place in a chemical waste container.
